Police Capt. Arrested?

22 year veteran under investigation

Although authorities will neither confirm nor deny it, reliable sources indicate that Capt. Darren Remillard, a 22 year member of the Hillsborough Police Department is being investigated for assaulting a man suspected of being involved with his wife. Chief David Roarick has referred all inquiries to the State Police who would confirm only that they are investigating a matter regarding the local department. According to State Police Lieutenant Wagner, they are investigating what appears to be a simple assault, but he would not identify

the parties involved. Chief Roarick met with the Hillsborough Selectmen in executive session on Tuesday evening but no action was taken pending a report from the State Police. It was further reported that two other officers, members of the newly formed police union, accompanied Remillard during the assault. The degree of their involvement is not known as the union is now involved in the interview process. Lt. Wagner expects the investigation to be completed by the end of next week. At press time, no charges have yet been filed.

Henniker considers fee based programs

During a review of the Athletic, Concerts and Patriotic Purposes budget line items, Henniker Selectman Leo Aucoin proposed that, in the future, all entertainment and athletic programs should develop programs to make them fee based

and self-supporting, without taxpayer dollars. After a lengthy discussion the board decided to retain funding for these programs in the 2012 budget, but to place an article on the warrant to see if the town favored such a proposal.

Advanced training at Henniker Rescue

The Henniker Rescue Squad is proud to announce that Catherine Kielwein, Ryan Hornblower, Gregory Aucoin, and Brennan Lorden have advanced their national certification of Emergency Medical Technician (EMT) from the Basic to the Intermediate level. Kathleen Rock and Amy Perkins have achieved national certification at the Basic level. EMT certification is broken into three progressive levels. The Basic level takes a minimum of 140 hours of classroom and hands-on practice time while providing a wide range of medical care skills including defibrillation, oxygen therapy, and other routine patient care functions.

The intermediate level takes an additional 180 hours of classroom, hands-on, and clinical training time. The Intermediate level technician is able to provide all of the Basic level skills, plus the administration of a limited number of medications, Intravenous (IV) & Intraosseous (IO) cannulation, cardiac monitoring, advanced airway interventions, and Continuous Positive Airway Pressure (CPAP) administration. The highest level of EMT is the Paramedic, which takes a minimum of 1200 hours. These members have achieved these certifications on their own time and we would like to extend a huge thank you to them and their families. Our members continually train to maintain their skills and certifications, so they can help you, our neighbors.

ConVal Special Ed Child Check Clinics

ConVal School District Special Education Dept. will be holding a Child Check Clinic for 3, 4 and 5 year old children living in the towns of Antrim, Bennington, Dublin, Francetown, Greenfield, Hancock, Peterborough, Sharon and Temple on Tuesday, January 24, 2012 at the Antrim Elementary School at 9:00 a.m. Snow date is Thursday, January 26, 2012. The purpose of the clinic is to identify 3-5 year old children who need evaluation/consideration for special education services. Parents who have concerns about their child's speech, language, or overall development (cognitive, motor, social or play skills) should call 924-7503 X2031 to register. Pre-registration is required. Child must be accompanied by a parent or legal guardian. Vision and hearing will also be screened.

Selectmen continue trimming Henniker budget

At their meeting on February 3rd, the Henniker Selectmen asked Town Administrator Chuck Connell to provide suggestions for cutting the budget by an additional \$90,000 in an effort to achieve a flat budget. Meeting again on February 9th Connell did just that by making cuts that, combined with those made on the 3rd, reduced the proposed tax rate from \$8.66/\$1000 to \$7.58. Connell's reductions included cutting \$52,000 from the Highway/Transfer Station budgets, trimming \$11,100 from the Police department and reducing the Town office and Executive Budgets by \$4,400.

Still working for a 0% increase the board cut a further \$35,000 by reducing legal by \$5,000, the ZBA by \$1,500, Fire/Rescue by \$7,500, Code Enforcement by \$1,000 and directing the sale of the town's 1978 Huff Loader and its 1996 CAT loader for \$25,000. Those sales required

the purchase of a new \$4,000 bucket for the department's backhoe. The proposal

now goes to the Budget Committee for its review.

Former Newbury man killed

A former Newbury man was one of four people killed in a murder-suicide on New Year's Day in California. Authorities say Matthew Saturley, 31, died of multiple gunshot wounds early Sunday morning at a home in Coronado, California. Saturley grew up in Newbury but had lived in Chula Vista, Calif., for the past several years with his wife, 7-year-old stepson and 5-year-old daughter.

Newport board slights championship coach

Having fired its Superintendent and suspended its High School Principal, the Newport School Board struck again by informing Larry Carle, the winningest football coach in school history that his contract was not being renewed.

Carle, who taught at Newport for 35 years, recently resigned his teaching position but not the position of varsity football coach he has held since 1989. During that time, he has won four state titles, most recently in

2010, and 140 games overall making him the winningest coach in Newport's football history. He was also Newport's varsity baseball coach through the 1980s into the mid 1990s winning the school's only state title in 1983 and guiding the Tigers to two other championship game appearances.

The Board's pre-Christmas notice shocked not only Carle but also Athletic Director Doug Beaupre, who has written the school board telling them of the mistake.

Henniker approves Public Works request


Public Works Director Carl Knapp briefed the Henniker Selectmen on his request for new equipment. The board approved a warrant article asking for \$145,000 to purchase a Front End Loader with \$60,000 coming from a Capital Reserve Fund and \$85,000 to be raised by taxation. Knapp believes the equipment can be obtained for a least \$10,000 less. The board also increased from \$25,000 to \$33,000 his request to refurbish the department's 2000 6 wheel dump/plow truck, but instructed Knapp to cut his overall budget by that \$8,000 increase.

Man caught by his own hidden camera

Nathan Morello, 27, of Peterborough pleaded guilty to one count of invasion of privacy for attempting to film patrons at a Milford gym. He was arrested last fall after police were notified of a hidden camera in a tanning room at Gold's Gym at the Granite Town Plaza in Milford. Court records indicate that the camera, disguised to look like a hook one would hang a towel or a robe on, was discovered by someone cleaning the tanning room. When authorities explored the camera's memory, they found images of Morello adjusting the camera along with images of a cleaning person working in the room. Police also found links to Morello's Facebook page. They did not find any images of any other Gold's Gym patrons.

John Stark budget is down over \$700,000

SAU# 43 Superintendent Dr. Lorraine Tacconi-Moore has presented a proposed 2012 John Stark budget of \$13,440,797 which is \$737,331, or 5.2% lower than the current budget. The proposed default budget is \$817,740 lower at \$13,360, 388. The reductions result from the payoff a bond, eliminating over \$500,000 in debt service and nearly \$200,000 by reducing three teaching positions.

Other warrant articles ask voters to approve a new teacher's contract costing \$90,502 in 2012-2013 and another \$79,992 in 2013-2014, and a support staff contract funded at \$6,278 in 2012-2013 and another \$19,303 in 2013-2014. Several members of Weare's Finance Committee were in attendance. The budget now goes to them for review and comment. As it stands, a Weare

homeowner with a \$250,000 home will see his taxes drop by \$52.50 and a Henniker

homeowner with a similar home will see a \$120.00 savings on the bill.

ConVal cuts 2 staff positions

The ConVal School Board's is proposing an operating budget of \$42,281,315, a 1.4% increase over the 2011-2012 figure. School Superintendent Dick Bergeron and his staff have worked with the board to tighten the budget. In order to reduce the budget, two staff positions were eliminated, a World language instructor at the middle school level and the high school's crisis counselor. Business Manager Marian Alese said other savings will come by using funds which remain in the 2011-2012 budget to pay for projects initially included in the 2012-2013 budget, including repaving the ConVal parking lot.

Former Superintendent slams Board

Former SAU #43 Superintendent Virginia Irwin has blasted Newport School Board Chairman Dick Jacobs "and his band of thugs" in an e-mail she sent throughout the town. Irwin called for "reasonable people to take back the Newport School District and do what school board members are legally responsible to do." Her complaint was triggered by the firing of Newport football coach Larry Carle and she claims "Dick is lying," when he claimed that the board was "under the impression" that Carle had resigned both

his teaching and coaching jobs. She stressed that it is the duty of the athletic director and the school principal to recommend coaches to the board for approval, and said "It was very clear to me that Larry resigned his teaching position only." Irwin wants Newport residents to get involved and find reasonable and responsible people to run for the four school board positions that will be open this year. "We must have reasonable people who care about good education," she said. See story Page 3 and Page 12 letter.

No one injured in Newbury barn fire

Newbury Firefighters with help from from seven other towns were able to extinguish a barn fire at Hopewell Farms on South Road on Sunday, but not able to save several chickens, piglets and fish. Fanned by strong winds and fueled by hay and other combustible material, the fire quickly rose to three alarms. Firefighters were able to keep the fire from reaching the family home, but about half of the barn was consumed in the fire, with damage estimated to exceed \$250,000 because of lost equipment and livestock. Hopewell Farms, owned by the Moran family, grows organic produce and raises goats, chickens and other livestock. It is best known for the Tilapia they raise. Theirs is the first such fish farm in the state. The state fire marshal is investigating, but the fire is not considered suspicious.

Two Peterborough homes hit by burglars

A pair of Peterborough residences were burglarized recently. According to Police Chief Scott Guinard, on January 1st, police were notified of a forced entry at a home on Snow Road. That afternoon, the daughter of a Sand Hill Road resident told police that she had gone to the house and found it had been broken into, with jewelry and electrical equipment taken. Police are collecting a full list of the items taken.

Newport renews NH Circuit Court lease

The Newport Board of Selectmen has authorized Town Manager Paul Brown to sign a two-year lease renewal with the State of New Hampshire for the Newport Circuit Court. The renewal is at a cost of \$83,671 annually, the same amount as the current lease. \$36,627 of that is allocated to pay for propane, electricity, supplies and building insurance, with another \$6,000 to \$8,000 to cover mowing, snow removal, repairs, as well as payroll and benefits for town employees performing those services.

Hancock crew saves man on Norway Pond

A 46-year-old Orange, MA man was taken to Monadnock Community Hospital Sunday after he slipped on ice on Norway Pond and hit his head. Hancock Fire Chief Nevan Cassidy reports that a Hancock rescue crew went to the town beach where they found the man conscious. He was taken off the ice, then transported to the hospital by Ambulance.

Hopkinton girl wins Legion oratorical contest

Sunapee Police Chief & Officer honored

Sunapee Town Administrator Donna Nashawaty recently presented the Gallantry Star award to Police Chief David Cahill and Sergeant E. Neil Cobb. The Gallantry Awards were presented to Chief Cahill and Sgt. Cobb of the Sunapee Police Department for their actions in the arrest of a wanted felon. The circumstances of the arrest were the result of a motor vehicle stop on November 29, 2011 in which it was revealed that the subject was wanted by the New Hampshire Probation and Parole Department for previous felony drug charges. During the arrest, the subject resisted and fled on foot causing injury to Chief Cahill. Both Sgt. Cobb and Chief Cahill continued to chase the subject and after a brief struggle, successfully arrested the subject. A subsequent search of the subject's vehicle revealed large quantities of illegal drugs, including cocaine, heroin, marijuana, crack and psilocybin mushrooms. The actions of both officers resulted in the removal of a dangerous felon from the community.

Henniker to update Hazard Mitigation Plan

Tia Hooper, Henniker Emergency Management Director and Nancy St. Laurent of the NH Emergency Management Office, met with the selectmen to request \$5,000 of additional funding to update the Town's Emergency Operations Plan and its Hazard Mitigation Plan. Towns are required to update their Hazard Mitigation Plan every five years and Henniker's is due in 2012. The plan must be current in order for the town to qualify for any FEMA grants. The town's Emergency

Operations Plan is good until 2013. After a long discussion the board approved an ad-

ditional \$2,500 for the Hazard Mitigation Plan, deferring the other for a year.

Odd Fellows Building Phase II

The Warner Selectmen recently discussed creating an informational warrant contingent upon grant money regarding the next phase for the Odd Fellows Building. Phase I was the environmental study on the building that was funded through a grant. Phase II would be the cost estimate for disposing of all the hazardous material in the building. Bennington may restore town Meeting

The Bennington Selectmen have approved a warrant article discarding the SB2 system and returning to a traditional Town Meeting. Conservation Commission Chair, Joe MacGregor proposed the article and the Board of Selectmen unanimously agreed to include it on the warrant. MacGregor believes the town lost much of its continuity and cohesiveness when voters gave up the Town Meeting. Bennington adopted the SB2 system in the late 1990's.


New London board upset but will pay

New London Hospital's request for nearly a 30% increase in the town's support has New London Selectmen upset but with few alternatives. The majority of the increase is to fund the ambulance service. An Ambulance Study has been underway to determine the possible options if the hospital discontinues its ambulance service. MRI Corp was contracted to complete the study by the end of the year so area towns could have the alternatives prior to Town Meeting. The board anticipates approving the hospital's request for \$121,393, knowing that any changes would take 18 months to two years to coordinate.

Community Wood Program in Warner?

The Energy Committee will be meeting with the Warner selectmen about creating a community wood program. Ideally the Energy Committee would like to see the program staged at the Transfer Station. The Selectmen's office will arrange to meet with Peter Ladd from the Energy Committee at the January 17th meeting. The Energy Committee is still looking for direction from the Selectmen. Selectman David Karrick said he would like to see the Committee implement some programs that would benefit the citizens and an overall energy plan for the future. Selectman David Hartman would like to see windmills in the Mink Hills and on Kearsarge Mountain Road to get the town off the grid, another idea is to have Market Basket solar dependent. Another idea is switching over to highly efficient LEDs in the town buildings instead of light bulbs as well as a program for households.

Hillsborough Selectmen aim for a flat budget

As it currently stands, Hillsborough's proposed 2012 budget reflects a 3.4% increase, but the selectmen are looking for further reduction in order to present voters with a flat budget. During Tuesday's meeting with Fire Chief Ken Stafford and Emergency Management Director Scott Murdough, some savings were achieved. Stressing that they understood the plight of local taxpayers both Stafford and Murdough were willing to examine their proposals for further savings. Murdough agreed to cut his request for new equip-

ment to outfit the emergency management trailer from \$10,000 to \$5,000 and Stafford reduced his request for increased per diem pay by \$10,000. The Fire Department has also agreed to delay its request to join Capitol Area Dispatch

which will save \$22,000.

Transfer Station Manager Luke Levesque urged the board to begin planning on how to deal with a potential closing of the Concord Coop in the next few years.

Burglary at Greenfield home

Greenfield Police are investigating a January 2nd burglary on Muzzy Hill Road. The residents were not home at the time of the burglary, but reported that jewelry missing when they returned home to find someone had broken the window on their front door to gain access to the house. The value of the items taken is unknown. There have been no similar break ins in the area.



TAKE YOUR MEDICINE



A study published in *Pediatric Pulmonology* shows promise for the use of azithromycin (Brand names: Zithromax, Zmax) in treating *Ureaplasma*-colonized or infected premature infants to prevent bronchopulmonary dysplasia (BPD).

Bronchopulmonary dysplasia is a chronic lung disorder characterized by inflammation and scarring in the lungs. It is common among premature infants, whose lungs are not fully developed at birth. This disorder can lead to chronic lung damage or death. Many infants who survive are at a greater risk for having recurrent respiratory infections, such as pneumonia or bronchiolitis.

Cholesterol-lowering drugs known as statins may help clot-busting drugs treat strokes, according to a study published in the journal *Stroke*. Within three hours after treatment, blood flow restoration in the 12 patients already on statins averaged 50 percent. In the 19 patients not taking statins, though, the average was 13 percent.

Researchers are suggesting in a report in *Cancer Biology & Therapy* that antioxidant dietary supplements, like N-acetyl cysteine (NAC) can also help prevent and treat cancers because they fight against mitochondrial oxidative stress – a culprit in driving tumor growth.

Kearsarge school budget down about 2%

Voters at the Kearsarge Regional School District Deliberative Session were presented with a budget of \$35,546,033, which is a 1.9% reduction from the current operating budget. A motion by Charles Forsberg to reduce the budget to \$0 was easily defeated. Other articles on the warrant ask for \$427,483 for teacher raises, \$25,000 for a Special Education Trust Fund, and \$35,000 for a part-time school Resource Officer.

Monadnock Hospital cuts three positions

Changes in the way Monadnock Community Hospital delivers physical therapy services to patients has resulted in the elimination of three physical therapy assistant jobs at the hospital and its satellite offices. Three physical therapy assistants were notified that their jobs were being eliminated last week. The hospital now employs 18 full or part-time physical therapists.

Bradford Town Hall Forum January 14

The Town Hall Restoration Committee is sponsoring a Town Forum for the Future of Bradford's Town Hall, to be held at the Bradford Elementary School on Saturday, January 14th from 10 a.m. - noon. Refreshments will be available. Everyone is invited and all views are welcome. Some of the questions and concerns include: What are our choices? What is the best plan for Bradford's future? What are current Town Hall costs? How will our decision contribute to community life for years to come?

Bennington Transfer Station's new hours

The hours at Bennington's Transfer Station and Recycling Facility are changing. A five week study revealed that the facility received high use on Sundays, despite fewer hours of operation. The Transfer Station currently operates on Wednesday, from 1 p.m. to 5 p.m., Saturday, 9 a.m. to 5 p.m., and Sunday, 1 p.m., to 5 p.m. The Wednesday hours will remain the same, but selectmen have decided to shorten the hours it will be open on Saturday and extend Sunday hours. Now, the facility will be open from 10 a.m. until 4 p.m. on both days.

New London Board approves 2% raises

The New London Selectmen have approved a two percent pay raise for full-time town employees. The salary increase of \$46,185 was approved by a vote of 2-1, with Selectman Peter Bianchi opposing after his proposal for a 1.5 % raise was voted down. In discussing employee benefit packages, it was pointed out that the town saved around \$70,000 last year, changing health insurance providers and choosing a plan with a higher deductible and lower premium. The town also decreased its contribution to each employee's premium, resulting in employees paying an extra \$21,900. Although it was pointed out that the employees still have better benefits than most residents, the board felt it to share some of the savings with them.

Francestown budget up to \$1.4 million

With the goal of keeping the increase in the town's tax rate under 3%, the Francestown Selectmen are proposing a budget of \$1.4 million for 2012, an increase of \$70,510. The proposed executive budget is up \$19,360 due to increases in payroll and professional development. The "highway and streets" budget is up \$24,379 and general expense in the Highway Department is up \$16,992. The Police Department wants an increase of \$12,765 and the Fire Department has asked for an increase of \$2,935. The budget is now in the hands of the Budget Committee to review and make adjustments to the Selectmen.

Warner considers closing Bartlett Loop

Warner Selectman Hartman went with the Director of Public Works to look at the condition of the culvert at Bartlett Loop. Hartman said the culvert is in desperate shape. At this time there is a metal plate over the culvert to allow for traffic flow for passenger cars only. Chairman Clyde Carson recommends a second opinion before closing the road and to meet with the area residents. David Karrick's opinion is to close the road since there is access from the other end. Hartman recommends another discussion with the Director of Public Works before making a decision at the next Selectmen's meeting.

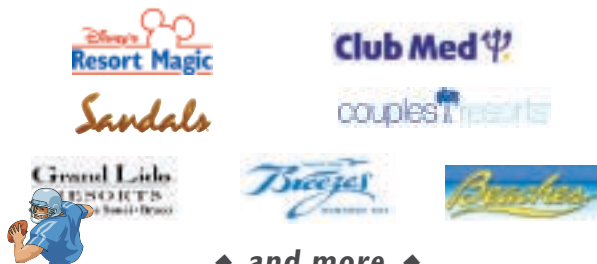
