## James Faulkner student helpers

### 2nd graders support Massachusetts explosion victims

Earlier this fall, first and second-grade students in Ms. DiMatteo's James Faulkner Elementary School class in Stoddard were learning about what a community helper is and how we are all global community helpers. When students heard about the gas explosions in Massachusetts during this same time, Ms. DiMatteo's

class decided to collect school supplies for those affected and illustrate how they could be global helpers. Students at James Faulkner collected over \$300 in binders, folders, crayons, colored pencils, markers, writing paper, backpacks, scissors, erasers, rulers, glue sticks, and pencils for students displaced by the gas explosions.

## Council delays vote to approve Sunapee lease transfer

The NH Executive Council has delayed voting on a contract that would enable Vail Resorts to take over operations of the state-owned Mount Sunapee ski area, citing last-minute amendments to the lease that need closer scrutiny.

In a 5-0 vote, the council tabled the request from Commissioner of Natural and Cultural Resources Sarah Stewart to approve three amendments, asking for more information from Stewart and Attorney General Gordon MacDonald.

Among the amendments, which councilors saw for the first time last Friday, are provisions that allow for expansion of the state park into nearby land, known as the West Bowl. The

previous lease-holder, The Sunapee Difference, owned 675 acres of undeveloped land west of the park, including about 150 acres that for years have been eyed for park expansion. Ownership of the private land was sold to Vail along with the lease to operate the ski resort, subject to state approval. Vail has said in public hearings on the lease transfer that it has no immediate plans to develop the land, but would like to keep the same development options that were available to the previous lease-holder.

The controversial West Bowl expansion, although never implemented, was approved by the Governor and Council in 2016 over the strong objections of conservationists and many neighbors to the resort.

## Franklin Senator & State Rep. want financial disclosure laws enforced

State Rep. Werner Horn, (R-Franklin) has filed a request with House attorneys asking them to draft a bill that would require more robust enforcement of the law (Chapter 15-A Financial Disclosures) that has been in effect since 2006.

"I plan to put legislation in that requires the attorney general to put an eyeball on this list and chase down whoever is not in compliance," said Horn, "and it adds a \$5,000 civil penalty." Gov. Chris Sununu says he will also be pushing for legislative action on the issue. State Sen. Harold French, (R-Franklin) says he raised the issue with the attorney general two weeks ago and is still waiting for an answer.

"It concerns me because I sit on the Joint Legislative Committee on Administrative Rules, which approves the rules put out by these agencies," says French. "The law is clear that you have to fill these out for transparency, and if you don't, you can't act on our behalf. So my question to the AG was how can I approve rules written by agency members who have no legal standing to present them."

Associate Attorney General Anne Edwards said the Department of Justice is in the process of preparing a response to French, which will be made public at

the beginning of next week. The list of required "15-A filers," as they are called, is maintained by the Secretary of State office and posted on the SOS website under "Administration." It is supposed to include everyone on a board, commission or agency with the power to sign contracts, accept bids or otherwise do business on behalf of the state.

The list currently posted consists of 46

pages with about 40 names on each page, for a total of about 1,840 names. Everyone who has filed has an "x" by their name. There are about 600 listings with no "x."

The list also contains some names of individuals who no longer work for the agency under which they are listed, or no longer work in state government. But there's no doubt that hundreds of people who should file have not done so.

## Hopkinton officials mum on reasons for office move

Hopkinton officials are not elaborating on why the Town Clerk's Office is being temporarily moved from the Bates building in Contoocook to the Town Hall. However, the minutes reflect that the Select Board approved the move based on advice of counsel.

Selectman Steven Whitley made the motion and was seconded by Selectwoman Sara Persechino, before passing on a 3-0 vote. Chairman Jim O'Brien who was absent from the meeting later said that he would have voted in favor

of the move.

The timing of the move seems odd in that the midterm elections are on November 6th.

Town Administrator Neil Cass confirmed that there is nothing wrong with the Bates building nor is it being renovated, however, when asked if there is a personnel issue or if there are any investigations into the office underway, he deferred to Chair Jim O'Brien. When he was contacted, O'Brien declined comment.

A bomb threat was made at the Hillsboro-Deering High School. Students were evacuated to the Middle School. Fire and Police were notified and responded immediately. The State Police Bomb Squad arrived and searched the building. When the building was deemed to be safe the students returned to class. The Police and School investigations are already in progress.

## TAKE YOUR MEDICINE



The U.S. Food and Drug Administration today approved Noctiva (desmopressin acetate) nasal spray for adults who awaken at least two times per night to urinate due to a condition known as nocturnal polyuria (overproduction of urine during the night). Noctiva is the first FDA-approved treatment for this condition. Nocturia (wakening at night to urinate) is a symptom that can be caused by a wide variety of conditions, such as congestive heart failure, poorly controlled diabetes mellitus, medications, or diseases of the bladder or prostate.

A clinical trial studying the use of Verapamil (a drug currently in use for cardiovascular disease and cluster headache) in alleviating chronic rhinosinusitis (CRS) with nasal polyps revealed significant improvement in the symptoms of this subset of patients. The first study was published in the *Journal of Allergy and Clinical Immunology*.

Nine years ago, researchers confirmed a new standard of care for patients with incurable gastrointestinal stromal tumors (GIST), who could survive by being treated with imatinib mesylate, the breakthrough drug marketed as Gleevec.

Now long-term findings from that study estimate that nearly one in four patients treated with Gleevec will survive 10 years. Results are published in JAMA Oncology. GISTs are different from more common types of gastrointestinal tumors because of the type of tissue in which they start. GISTs belong to a group of cancers called soft-tissue sarcomas. Soft-tissue sarcomas develop in the tissues that support and connect the body, including muscles, nerves, tendons, and joints. GIST is a rare cancer, with about 6,000 new cases diagnosed in the United States each year.

# New Boston Bulletin

After our Monday evening Board of Selectmen’s meeting, we felt it was important to reach out to our residents in an effort to provide you with important information regarding what we’re facing this year as we approach budget season – yes, it’s that time of year again! The Capital Improvement Programs (CIP) Committee has already begun to meet. They work to assist with long term planning for larger expenses, like Dump Trucks, Fire Trucks, Building Improvements, etc. These expenses are paid over a number of years and you would see them referenced in Warrant Articles on the Town Warrant.

The Finance Committee, a group tasked with reviewing all the budgets and making recommendations to the Board of Selectmen, begins meeting on November 1st. Their meetings are all open to the public, and the Board encourages residents to come and listen to the Department managers present their budgets. All Town meeting times and dates can be found on the Town Meeting Calendar on our Town Website.

This year preparation of the Town Budget will be a little more challenging than usual. In 2018, we’ve been operating with a default budget. Although it’s difficult to cover all our needs with less than what was requested, we’ve been able to “make due” in large part because we’ve had the ability to cover “contacted” items at the higher amount in our default budget.

That has all changed for the 2019 tax year based on new legislation that was unfortunately supported by our local representatives. Next year, if a contracted service increases in cost, our default budget must use the last years’ approved cost if the operating budget fails to be passed by the voters. A clear example of the position we could find ourselves in involves our contract for dispatch services with Goffstown. In 2018 the Fire Department spent \$3,800 for dispatch services, but in 2019 that contracted cost will go up to \$15,000 (even with this increase, Goffstown provides the most cost effective option of any of the other vendors in NH). Should we find ourselves working with a default budget next year, the \$11,200 difference in cost will need to be found somewhere else in the Fire Department budget – a difficult task when our budgets are so lean to begin with, and yet the department can’t run without dispatch services.

Another risk we’re facing if our Operating Budget fails to pass concerns the Town Halls’ IT systems. Our server is 3 years past Warranty and had a major failure this spring. Recovery took days and resulted in the Town Hall operations coming to an almost complete halt. If you were one of the residents who attempted to register your car that week, you know what we’re talking about. We are also facing the need to replace 12 of the 15 computers which are running on an operating system that will no longer be supported by Microsoft in January 2020. We will be asking for the money for these vital upgrades and hope the residents of the Town support us with their votes.

Please consider coming out to the Finance Committee meetings, the Public Budget Hearing and/or the Deliberative Session, and also stay tuned for more information from the Board of Selectmen over the coming months leading up to the March vote.

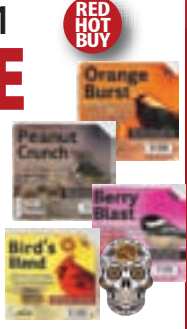

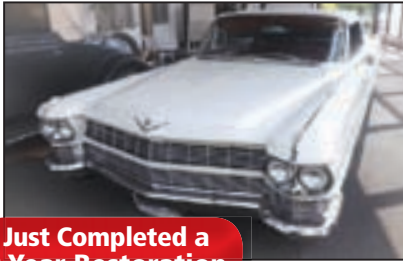
