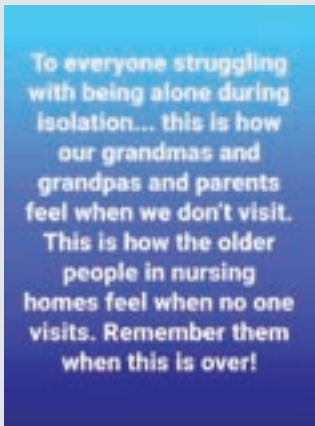

COVID-19 is being contained

Officials urge continued precautions & social distancing

State Epidemiologist Dr. Benjamin Chan said New Hampshire's aggressive strategy to prevent the spread of COVID-19 should cut the number of possible infections and deaths by more than half. A leading health research institute at the University of Washington last week dropped earlier estimates for New Hampshire fatalities from more than 350 down to 32.

"Early data shows that our New Hamp-

shire strategy appears to show early signs that we are starting to control the spread of COVID-19," Chan said.

Chan also said the state's peak for the outbreak still appears to be coming in the "next several weeks." All 21 deaths in New Hampshire have been adults either over 60 years old or those who had chronic, underlying medical conditions that put them at high risk from the virus.

Renovation and rebuilding of Peterborough Library begins in May

The Town of Peterborough, the 1833 Society and the Library Trustees have announced the library will break ground in late May of 2020. The most recent effort to renovate and rebuild the Peterborough Town Library began in 2011 and is moving forward after nine years of careful planning and community input and support.

“The Peterborough Town Library holds an incredible amount of history and is an invaluable resource for the entire region. I have been completely blown away by the dedication of the 1833 Society, Leo Smith the town finance director, as well as the tireless efforts of Corinne and her staff. It’s another fabulous example of how fortunate we all are to call Peterborough home. It’s been my honor to play a small part in getting this project to the construction phase. This community effort to bring together a public-private endeavor of this magnitude is another important moment in the history of The Peterborough Town Library,” said Bill Taylor, Select Board member.

Harvey Construction, Bedford, will oversee the project along with Ann Beha Architects, Boston. Construction will take approximately 15 months. To view a 3D walkthrough of the design, visit PeterboroughTownLibrary.org/LibraryProject. The historic 1892 portion of the library will be restored and the 1957 and 1978 wings will be demolished and replaced with a sustainable HVAC system, ADA compliant entrances, an elevator, and vastly improved spaces for the public. “The heroes of this project are the residents, volunteers and generous donors,” said Library Director Corinne Chronopoulos. “The 1833 Society led the effort

to raise more than \$5 million in private funds, more than \$830,000 of which was donated by the Library Trustees from their proprietary funds. The Friends of the Library played a vital role, donating \$75,000. In addition, the taxpayers of Peterborough contributed \$3 million as part of the warrant article passed in 2018 with 80% approval. I’m so proud our town supports a public library that creates powerful literacy opportunities, offers access to information as a basic right to all residents, and contributes to the vitality of our community. This is a public building worth investing in for tomorrow.”

The library renovation will be completed parallel to work on the Main Street bridge. Both projects will be coordinated and completed within the next two years. The library is currently closed due to the COVID-19 pandemic and will reopen at a temporary location to be announced soon. Plans for a virtual goodbye walkthrough are underway. The library pivoted to a virtual platform in March and continues to offer a full slate of online programming, a robust eLibrary collection, and employment and career coaching services. 440,699 people worldwide have recovered from Covid-19

More than 41,000 people in America have recovered from the coronavirus, and recovered patients could be key to reopening the country. Based on how previous viruses have behaved, officials believe those who have recovered will have at least some immunity, meaning their return to daily life may be less likely to fuel an outbreak.

The United States has had the larg-

est outbreak worldwide and more than 2,816,000 people have been tested. Of those people, 557,500 had positive test results and 22,109 died, according to the Johns Hopkins University tracker. As of Monday, 41,831 people in America were deemed "recovered," according to the tracker. Worldwide, 440,699 people have recovered, the tracker reported.

Windsor man confined to psychiatric hospital, faces multiple charges



Dylan Stahley, 22, of Windsor has been transferred to the state's psychiatric hospital. Stahley was initially admitted to Concord Hospital for treatment of non-life-threatening gunshot wounds. He was medically cleared last week but awaiting involuntary emergency admission to New Hampshire Hospital, but did not have a bed available for him at that time

The Attorney General's Office has announced that the officer that shot Stahley was Trooper Michael Petrillo, who has been with State Police for about six years, according to the Attorney General, "The circumstances surrounding this incident remain under active investigation, and a report regarding whether the use of force was justified will be released once the investigation is completed."

Court records show that Stahley has a history of mental illness. He was previously admitted to New Hampshire Hospital last year.

According to a sworn affidavit, Stahley was armed on the ball field near the new skate house at White Park and refused to comply with officers' commands to drop the gun.

Police allege Stahley broke into the skate house just before midnight Saturday. He now faces charges of burglary, reckless conduct and being a convicted felon in possession of a deadly weapon.

TAKE YOUR MEDICINE

Children with asthma are more likely to be prescribed antibiotics even though there is no evidence that they need them any more than children without asthma, according to research presented at the European Respiratory Society International Congress 2017. Overuse of antibiotics is leading to a rise in drug-resistant infections; unnecessary use in children could leave them more at risk of a future infection that is difficult to treat. The researchers say their results may indicate that asthma symptoms are being mistaken for a respiratory tract infection, or that the antibiotics are being given as a preventive measure, even though guidelines do not support this.

A new study published in the *Journal of the American College of Cardiology* finds beta blockers are not needed after a heart attack if heart-attack survivors are taking ACE inhibitors and statins. Heart-attack survivors are usually prescribed all three drugs to help prevent a second attack and death. However, the beta blockers offer no additional benefit for patients who take the other two drugs as prescribed, according to the new study, which examined the trade-offs and consequences of using some of the medicines instead of others.

Older people who use steroid inhalers for asthma or chronic obstructive pulmonary disease (COPD) are more likely to suffer particular bacterial infections, according to a large study published in the *European Respiratory Journal*. Worldwide, asthma and COPD affect hundreds of thousands of people and they are commonly treated with steroid inhalers to reduce symptoms and improve lung function. However, the new study suggests that these inhalers also increase the risk of lung infections caused by nontuberculous mycobacteria, which are notoriously difficult to treat and resistant to a number of common antibiotics.

Campbell Scholarship deadline extended

The Eleanor Campbell Charitable Fund Scholarship Committee has announced an extended deadline of May 4 for high school seniors and college students to apply for 2020 scholarships. New Boston's Nathan Noyes confirmed to lead NH State Police

Members of the Executive Council voted unanimously this week to confirm State Police Capt. Nathan A. Noyes of New Boston as Colonel of the New Hampshire State Police.



Noyes succeeds former Col. Chris Wagner, who retired March 2 after a little more than three years in the position and nearly 25 years in law enforcement.

Noyes was nominated for the position last month by Gov. Chris Sununu, and was sworn in as colonel by Sununu Wednesday afternoon.

"Congratulations to Capt. Nathan Noyes of New Boston on his unanimous confirmation to serve as the next colonel of the NH State Police at today's Executive Council Meeting," Sununu tweeted on Wednesday. "I look forward to working with him to ensure that NH remains one of the safest states in the nation."

Before being sworn in as colonel, Noyes served as commander of the Field Operations Bureau for Field Area III. He has served as a New Hampshire state

trooper since 2001 and previously held the ranks of troop commander, assistant troop commander, patrol supervisor, and trooper. His father, New Hampshire Police Sgt. James Noyes, was killed in the line of duty in Gilford in 1994 when Noyes was 16. Noyes has received several

honors, including the Congressional Law Enforcement Award.

"It is with the utmost sense of honor, pride and integrity that I will serve our state, our communities, and my beloved fellow state troopers," Noyes said in a statement.

RADON MYTHS AND FACTS — PART II

MYTH: Radon is only a problem in certain parts of the country.

FACT: High radon levels have been found in every state. Radon problems do vary from area to area, but the only way to know your radon level is to test.

MYTH: A neighbor's test result is a good indication of whether your home has a problem.

FACT: It's not. Radon levels can vary greatly from home to home. The only way to know if your home has a radon problem is to test it.

MYTH: It's difficult to sell homes where radon problems have been discovered.

FACT: Where radon problems have been fixed, home sales have not been blocked or frustrated. The added protection is sometimes a good selling point.

MYTH: I've lived in my home for so long, it doesn't make sense to take action now.

FACT: You will reduce your risk of lung cancer when you reduce radon levels, even if you've lived with an elevated radon level for a long time.

MYTH: Short-term tests can't be used for making a decision about whether to fix your home.

FACT: Short-term tests can be used to decide whether to reduce a home's high radon levels. However, the closer the short-term testing result is to 4 pCi/L, the less certainty there is about whether the home's year-round average is above or below that level.

Superintendent announces no April vacation for ConVal students

Superintendent Dr. Kimberly Rizzo Saunders of the ConVal School District has decided to cancel April vacation while continuing remote learning. In an email to families on Wednesday after polling parents, staff, administrators and School Board members she wrote, "More than two-thirds of parents who responded to the survey opted for this option, as did a large number of staff. Doing this will result in us ending the school year a week early," she said.

Vacation was scheduled for April 27 to May 1. The District is waiting on information from the state before setting the final date of the school year. The District received from about 500 parents with 97% saying that the school had been communicating effectively, and 92% felt their students were either engaged or highly engaged with the online material.

Respondents were devised over the workload required. While some praised an appropriate amount of work, others believed there was too little work, or too much work and too much screen-time. The District began implementing "flex days" every Friday, starting April 10, to

allow students to catch up on work or do one on one enrichment with teachers and

staff, and for staff to do outreach and collaborate with one another.

Democrats sue Sununu over Covid-19 funds

Top NH House Democrats filed a lawsuit Monday morning in an attempt to force Governor Chris Sununu to get permission from lawmakers prior to spending the \$1.25 billion stimulus package, reports NHPR. The lawsuit follows a tense week in which House Democrats claimed Republican Governor Sununu is cutting them out of the plan on how to respond to NH's financial threat due to the pandemic. Sununu claims that he has a greater leeway during the state of emergency to act without legislature approval. Sununu and Attorney General Gordon MacDonald point towards prior instances to back their argument, like the 2002 law which gives governors power to act unilaterally during emergency. Democrats argue that prior governors spent federal aid with the consent of the fiscal committee, pointing towards the flooding in 2003 and 2008 to boon their case. Sununu plans to stay course, and called the first meeting of a bipartisan COVID-19 "legislative advisory board" on Monday.

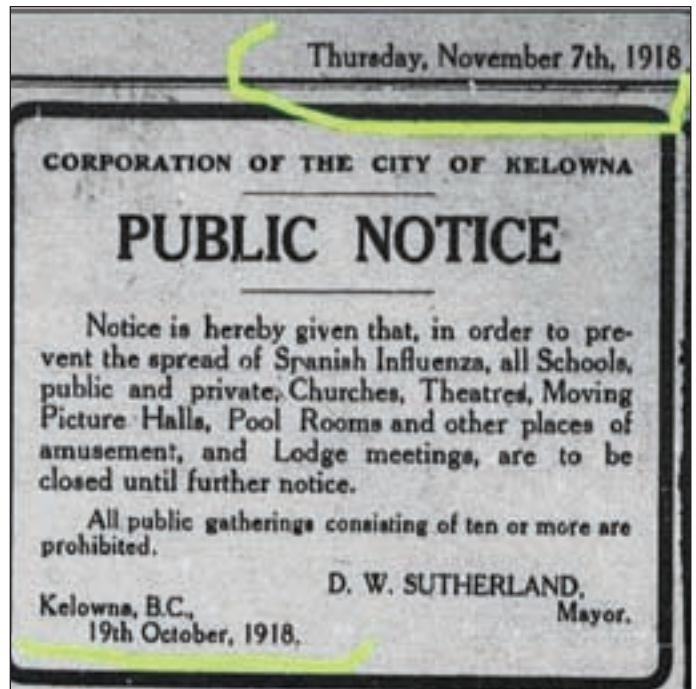
Fire Permits needed prior to open burning

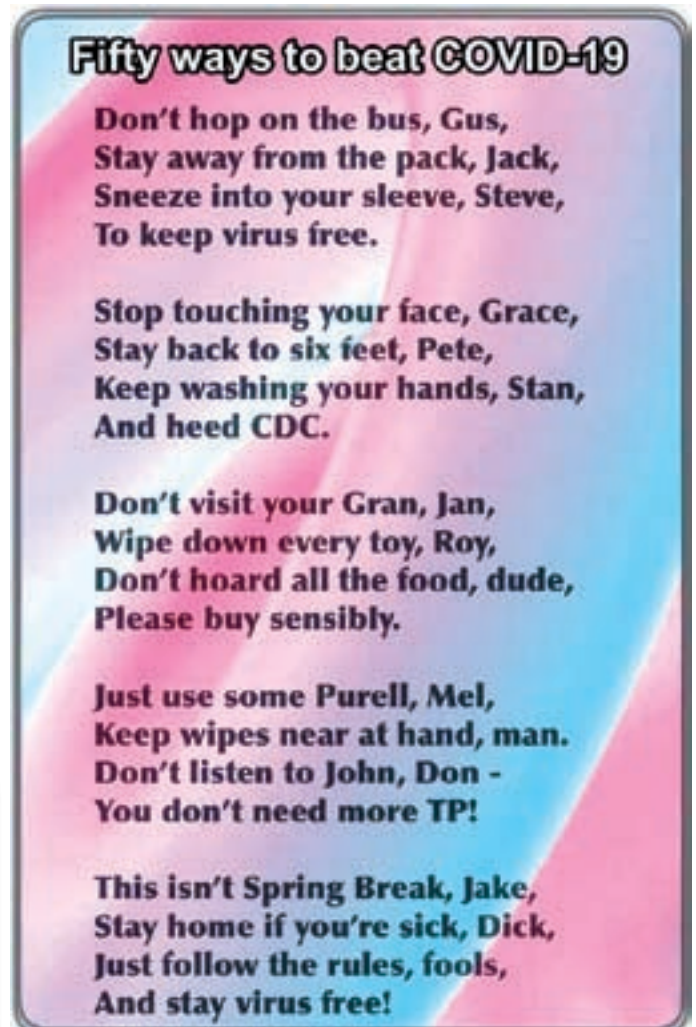

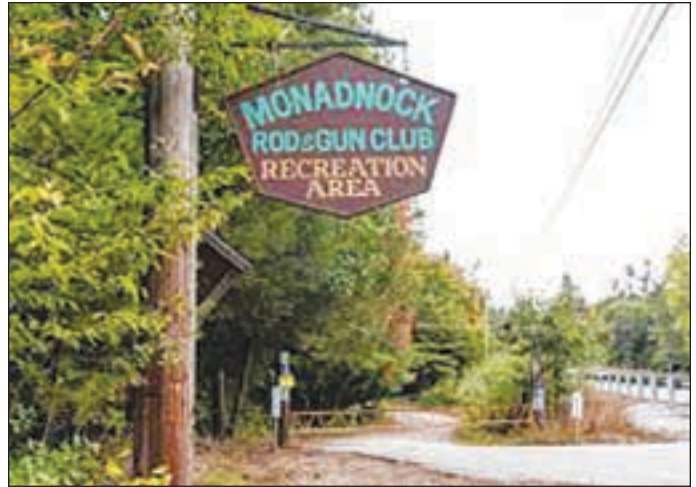

Monadnock Rod & Gun Club

Monadnock Rod & Gun club to pay \$650,000

Under continuing legal fire, Peterborough's Monadnock Rod and Gun Club has been ordered to pay \$650,000 to the neighbors on whose property the club built its firearms range.

The club, which has been in existence since 1947, brought a lawsuit against Scott and Bridgette Perry over the firearms range. The range extended onto the Perry's Old Jaffrey Road property, and the club sought a ruling so that it could take the land through adverse possession. Club President Mark Carbone, who also is representing the club in court, could not be reached for comment Monday. The damages order, issued March 25 by Judge David Anderson, indicates that no one from the club attended the March 3 damages hearing. The Perrys had three experts testify about the damage done to their land when the club filled in the wetlands to build parts of the range, according to the court order.

The soil used for fill is now considered contaminated, according to the order. The total to remove the soil and remediate the land is \$648,402, according to the experts who testified on behalf of the Perrys, according to Anderson's order. Anderson did not order the club to pay attorney fees to the Perrys.

Bridgette Perry said Monday the range was built around 2010 as a 50 yard gun range and was expanded over the years to a 200-yard range. When the Perrys discovered the range was on their land, the club's board initially offered \$10,000 for the property, she said. The couple refused, at which point the club sued them, she said.

The firearms range has been silent since 2018, when the town was granted an injunction against the club. Peterborough's Deputy Town Administrator Nicole McStay said Monday the town will file its own lawsuit against the club before the end of the month.

Peterborough previously sued the club over alleged land use violations but held off while the Perry case proceeded, McStay said in an email. The club had the only outdoor range in town before the shutdown. In 2018, voters adopted a zoning amendment that outlaws all new outdoor gun ranges.

Attorney General warns that scam artists are targeting elderly

Scams associated with coronavirus appear nowhere close to abating. “In recent weeks, scammers have used the uncertainty and isolation brought about by the COVID-19 pandemic to attempt to obtain personal identifying information and assets of aging adults across the country,” warned New Hampshire Attorney General Gordon J. MacDonald in a statement. MacDonald’s office issued a list of some of the scams currently aimed at aging adults, with recommendations for what to do if a scammer contacts you.

Social Security Scam

Scammers claiming to be from the Social Security Administration call a recipient and claim that because of the closing of SSA offices, the recipient’s benefits will be interrupted unless he or she provides personal identifying information, such as a Social Security or bank account number. The SSA will not call a recipient unexpectedly and ask for personal information over the telephone. If you receive a call like this, hang up and report it to the SSA at <https://oig.ssa.gov/>

Medical Scams

Scammers are calling aging adults pretending to be a family member (often a grandchild) and claiming they are in need of money to treat COVID-19 symptoms. Sometimes, the caller will ask the aging adult to send gift cards or cash for payment.

“These types of calls are called ‘grandparent scams,’” MacDonald said in a statement. “They can be frightening and distressing. If you receive a call like this, you should hang up immediately.”

Scammers also are contacting people by telephone, e-mail and sometimes in person, offering COVID-19 home test kits, medicines or vaccinations. Currently, no vaccines, pills, potions, lotions, medications or other prescription or over-the-counter products are available to treat or cure the disease.

Stimulus Scams

With many aging adults set to receive stimulus payments from the federal government, scammers are calling, texting and e-mailing aging adults claiming to work for federal agencies, such as the Internal Revenue Service, asking for

the aging adult’s personal identifying information before stimulus payment disbursement. The AG’s office said no federal agency is going to call, text or e-mail requesting Social Security, banking or any other personal identifying information.

Fake Charities

Scammers are contacting aging adults claiming to be from reputable charities or fictitious charitable organizations, seeking donations for a variety of causes related to the COVID-19 pandemic. Many of these scammers request payment in the form of gift cards or electronic currency, such as bitcoin.

Nashua joins ConVal's school funding suit against the State of NH

The Nashua School District is joining the fight in the ConVal School District lawsuit that declares the state's school funding to be unconstitutional.

With a unanimous vote, the Nashua Board of Education decided Monday to sign onto a New Hampshire Supreme Court brief that supports the ConVal adequate education funding lawsuit.

Nashua is the latest in a line of school districts to express their support for the lawsuit, including Manchester, Concord and Keene. With Nashua now on board, more than 30 percent of the students in the state will be represented, according to attorney John Tobin.

"I think the Supreme Court will pay attention to that," said Tobin, who said he will be writing the brief and filing it with the court on either Friday or Monday.

Tobin is working without pay on the litigation, which does not commit the Nashua School District to any further involvement in the ConVal case.

"The state is only paying about 31 percent of the costs to schools," said Tobin, maintaining that in Nashua, the school

district is paying 62 percent of its overall costs — twice as much as what the state offers the city.

The court brief gives the city a voice, according to Tobin, who said the current education funding system is dependent on how much property there happens

to be in each district, which he claims is unfair.

"The cost shifting has gotten a lot worse in the past decade," he contended.

The ongoing school funding lawsuit is currently on appeal with the New Hampshire Supreme Court.

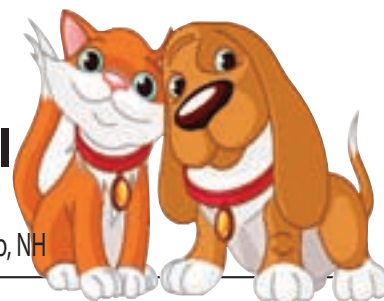

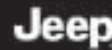

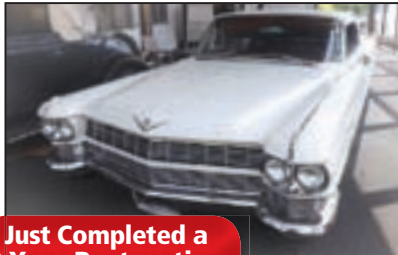
