## Weare Police Chief Jailed

*Every minute the Chief spends in jail is another dollar for the food pantries*

Weare Police Chief Christopher Moore spent a good part of last weekend in jail and is proud to have done it. The Chief was raising money for the town's two Food Pantries during the town's Patriotic Celebration.

Every dollar donated keeps the Chief behind bars for another minute inside a makeshift jail cell in a town park. The Chief said he saw other

departments hold fundraisers like this when he was a kid and is happy to do the same now.

He also said the officers on his force are enjoying this as well. "I love the support of the community so far and I'm more than happy to sit in there and I think my wife is too," Moore told WMUR. Local Boy Scouts built the jail out of wood and PVC

pipe.

Thanks to humble and dedicated efforts the project raised \$4,564.04, which will be split between the Town of Weare Food Pantry and the Pantry for the Senior Center, each receiving \$2,269.52.

Chief Moore said the department is planning to do something like this again next year.

## Deering making progress filling vacant Fire/EMS Chief position

Deering Town Administrator Peter Flynn informed the Select Board that there has been good response for the Fire/EMS Chief position and the town has received five applications.

Communication with Acting Chief Connor has been great and the department had their first meeting in many months where 75% attended and it was positive.

Acting Chief Connor secured a fire official to be on the hiring committee. He also credited Deputy Chief Murdough and Captain Rousseau for doing a great job during this time.

# New London Select Board reviews Dispatch Center budget

Town Administrator Kim Hallquist reviewed the method used to set the dispatching fees with the New London Select Board. The number of calls for service each member town has is used to arrive at the percentage of calls for service that will be used to determine the percentage of the budget the member town will pay, plus a \$3,000 user fee. The calls for service are averaged over a three-year period to avoid the impact of a one-year spike in calls.

The town's dispatching budget, plus \$34,000 for the payment into the capital reserve fund, is shared by the member towns that get dispatching services based on the number of calls plus the \$3,000 fees. New London's percentage has been 62%-67% over the past several years. In the past the police and fire chiefs, along with Chair Kidder, went to the member towns to make sure they were

happy with the service. Chair Kidder noted that improvements were made to the repeaters to ensure that radio coverage was acceptable.

Selectman Casey noted that she spoke with the Town Administrator about how the fees are set so she understands how it works. She noted that much of the budget is employee expenses and those costs do go up. Selectman Casey noted that she would like to hear from the Chief on the importance of dispatching services to the town.

Chief Cobb noted that an important point to remember is that the dispatchers are familiar with the towns so that when they get a call, they know the locations which results in better service for citizens. The three-year call average is helpful for dips in calls for service as well as the spikes.

Chief Cobb noted that she was not sure how the \$3,000

user fee was arrived at but could check if the Board wanted more

info. She pointed out that the new dispatch software will im-

prove services and equipment is updated as needed.

# Release of water from Stoddard dam causing flooding in Antrim

A controlled release at the Island Pond Dam in Stoddard on Monday night is causing water to rise along Liberty Farm Road in Antrim. People in the area are being told to get to higher ground or to an upper level of a home.

The Island Pond Dam water was released into the North Branch River, according to Antrim Fire Chief Marshall Gale. He said the flashboards at the Highland Lake Dam in Stoddard has some issues, discharging all the water into Island Pond, which was already at capacity and started to flood some homes.

Gale said he received confirmation that the dam will not fail. "The dams are not going to fail, they're performing as they were designed and engineered. But just be aware of the rising and high water," Gale said.

The fire chief said access to the bridge on Liberty Farm

Road is impacting about 18 homes.

Areas around Alstead, Acworth and Bradford are also starting to see more flooding.

Fire officials in Alstead said a woman's car was trapped on Fairbrooke Road. She stopped to call 911 when the water carried her and her car into the brook. The fire department managed to help her out and she is OK.

Acworth Fire Chief Gary Barber said 12 people were rescued from their homes on Route 125A.

He said several cars were swept by water but there were no injuries in those incidents.

Officials emphasize not removing barriers or going around barriers because it not only puts yourself in danger but first responders as well.

Officials said if water is going over a road or bridge, do not drive over it.

"In Antrim, we have closed

the Liberty Farm Bridge because the water is over the bridge and is starting to peel

up the tar," Gale said. "So, obviously it's not safe for traffic." The National Weather Ser-

vice says 12 inches of water is enough to float a car or small SUV.

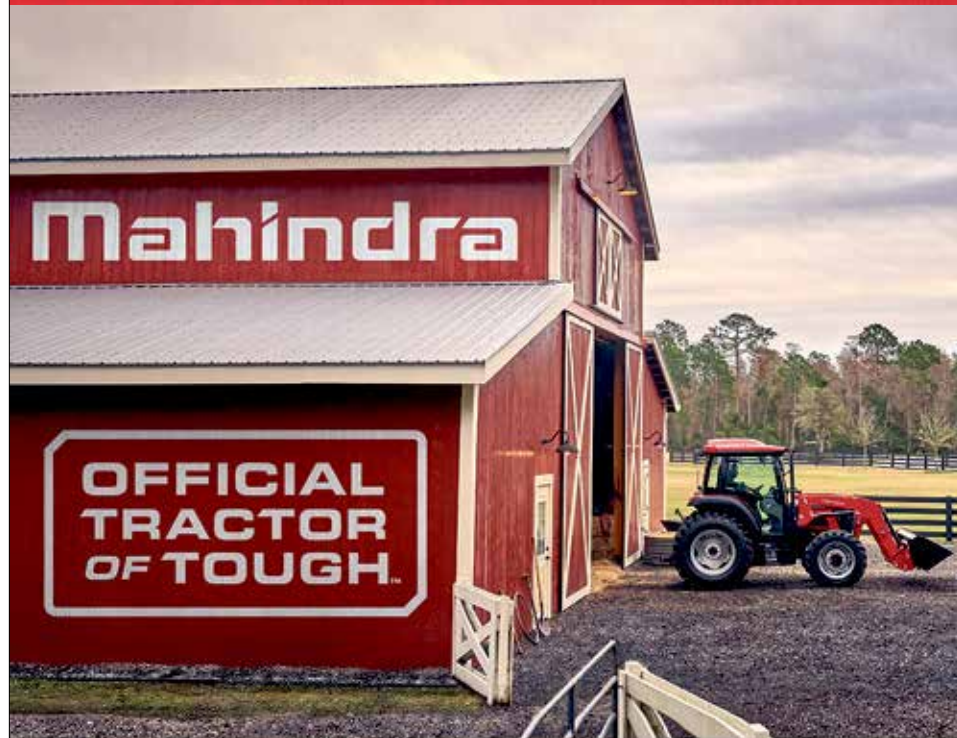

# Two victims die in early evening house fire in Sutton

New Hampshire State Fire Marshal Sean P. Toomey, New Hampshire State Police Acting Colonel Matthew Shapiro, Sutton Fire Chief Cory Cochran and Sutton Police Chief Jonathan Korbet announced that a fire occurred at 13 Brown Road North in Sutton on July 9, 2023, at about 8:30 p.m. Two victims died as a result of this fire.

The Sutton Fire Department was dispatched to 13 Brown Road North for a reported building fire. When the fire department arrived, they

found the single-family structure to be fully involved with fire. After the fire was extinguished, two deceased victims were found inside the house.

The Sutton Fire Department was assisted in extinguishing the fire by New London, Wilmot, Newbury, Warner and Bradford. New London Hospital Ambulance Service provided EMS coverage. Positive identification of the victims and cause and manner of their deaths are pending an autopsy.

The investigation into the

origin and cause of the fire is active and ongoing by mem-

bers of the State Fire Marshal's Office, NH State Police

and the Sutton Fire and Police Departments.



On Monday, July 10th Troopers assigned to the #NHSP #TroopD Barracks responded to a call of a body that had been found in Highland Lake in Andover, NH. Additional Officers and Troopers from the Andover Police Department, Marine Patrol, and the Major Crime Unit responded to investigate. The body had been discovered and reported by a resident on West Shore Drive. This investigation is ongoing, and the immediate cause of death is not known. An autopsy is tentatively scheduled by the Office of the Chief Medical Examiner, and the identity of the individual will be released once next of kin is notified. There is no additional information available at this time.

## Newport para-educator charged with sexual assault

A man who worked as a paraprofessional at a private school in Newport has been charged with sexually assaulting a 14-year-old student. Isaiah Grenier, 34, of Newport, was charged with aggravated felonious sexual assault, felonious sexual assault and

sexual assault. Grenier was a paraprofessional at the Granite Hill School, a school for children with special learning needs where the girl was a student. School officials told police they had not been able to get in touch with him since the end of May.

## Several Newport businesses impacted by severe flooding

Several Newport businesses were dealing with the recent flooding as the water started to slowly recede following heavy rain. “The amount of rain and water we got over the past two days has really caused a lot of problems here in town,” Fire Chief Steve Yannuzzi said.

At least three roads were closed Tuesday after washouts, and several businesses were affected. Michael Shawver, owner of Promex Service Center, said there was 4-5 feet of water in the building’s basement.

“My guys got here this morning and said it was flooded, so I came up and got the water pump out,” he said.

Shawver said he had to borrow two pumps from the fire department and was clearing the basement for over an hour.

“Our power is out right now, so that makes things a little

difficult, but otherwise, not too bad,” he said. “Most of our customers have been understanding. It’s just out of our control.”

Nearby, a small lake formed on the side of a Shaw’s and Ocean State Job Lot, but Yannuzzi said conditions had improved.

“The waters are already receding,” he said. “This morning, when I came into work, John Starks by the Shaw’s Plaza was completely underwater.”

The water was deep enough to get Pat McFarlin’s four-wheel-drive Jeep stuck.

“We’ve been here since 9, 10, a couple hours,” McFarlin said. “They say don’t drive through water, and we did it for fun. We won’t again.” Yannuzzi said people should avoid driving through flooded areas because they could get stuck, and it can damage the road.



The Newbury town docks are closed because of high water over the docks. Boaters on Lake Sunapee are advised to keep away from the Newbury dock as there is no safe access to the shore.

## TAKE YOUR MEDICINE

Less than half of Americans who received treatment for opioid use disorder over a five-year period were offered a potentially lifesaving medication, according to a new study published in the journal *JAMA Network Open*. And treatment with the medication was even more rare for those with what's known as polysubstance use disorder — when opioid users also misuse other substances, such as alcohol, methamphetamine, benzodiazepines or cocaine. The potentially lifesaving drug, buprenorphine, has been shown to reduce overdose risk — yet an analysis of health insurance data involving about 180,000 people treated for opioid use disorder showed that nearly 53% of the patients with the disorder alone were not prescribed the medication. Among those with polysubstance use disorder, the number prescribed buprenorphine dropped to about 30%.

When a person nearing the end of life enters hospice care, their hospice agency's doctors may prescribe a "comfort kit" of small amounts of medications that their caregivers can give them in case of urgent, distressing symptoms such as severe anxiety, agitation, delirium, nausea and more. They may also get other prescriptions as their hospice care goes on. But a recent study published in the *Journal of General Internal Medicine* shows massive variations in which hospice patients actually get two types of powerful medications — benzodiazepines and antipsychotics — that act on the brain. Such drugs have been the focus of efforts to reduce their use in older adults in other settings due to dangerous side effects such as falls, confusion, and sedation. While using medications to sedate hospice patients may be appropriate in many cases at the very end of life for advanced cancer, hospices increasingly serve patients with dementia and other conditions who are not imminently dying. In those cases, patients and families may want to avoid sedation to maintain alertness and ability to interact with others.

## MORTGAGE POINTS DEDUCTION

You usually have to pay "points" to the lender when you take out a mortgage. In most cases, the points you pay on a loan to buy, build or substantially improve your primary residence are fully deductible in the year you pay them.

On the other hand, if you're buying a second home, you can't deduct the loan points in the year you pay them. But you can still deduct them gradually over the life of the loan. That means you can deduct 1/30th of the points each year if it's a 30-year mortgage. That's \$33 a year for each \$1,000 of points you paid — not much, maybe, but don't throw it away.

When you refinance, you also typically have to deduct any points you pay ratably over the life of the new loan. However, if you use part of the refinanced mortgage proceeds to substantially improve your primary home, you can deduct the part of the points related to the improvement in the year you paid them if certain requirements are met (you can deduct the rest of the points over the life of the loan). Also, in the year you pay off the refinance loan (e.g., because you sell the house or refinance again), you get to deduct all as-yet-undeducted points.

There's one last catch, and it applies whether you're deducting points in the year you paid them or over the life of the loan. You must itemize to claim the deduction (Most people take the standard deduction instead of itemizing).

## IMPORTANCE OF BABY TEETH

**Q:** How important can baby teeth be? They just fall out on their own.

**A:** It is a misconception that baby teeth are not important and, further, the misconception often leads to an overall disregard for dental care when it comes to young children. Baby teeth with decay, however, can infect emerging permanent teeth, resulting in the need for a filling or extraction, according to the dentistry professor at Case Western Reserve University School of Dental Medicine in Cleveland who is leading a \$1.6 million study aimed at encouraging parents and caregivers for children from kindergarten through fourth grade to seek dental care for them.

The Case researchers are working with colleagues from the University of Washington Northwest Center to Reduce Oral Health Disparities in Seattle. The study is funded by the National Institute of Dental and Craniofacial Research and will generate educational material designed to convince the 660 parents and caregivers targeted in the study to take steps to protect the oral health of their young charges.

In prior research that led to the new study, only 20 percent of parents who were told their young children needed dental treatment actually took their children to a dentist. The fact is that decayed baby teeth can have a negative effect on emerging permanent teeth. 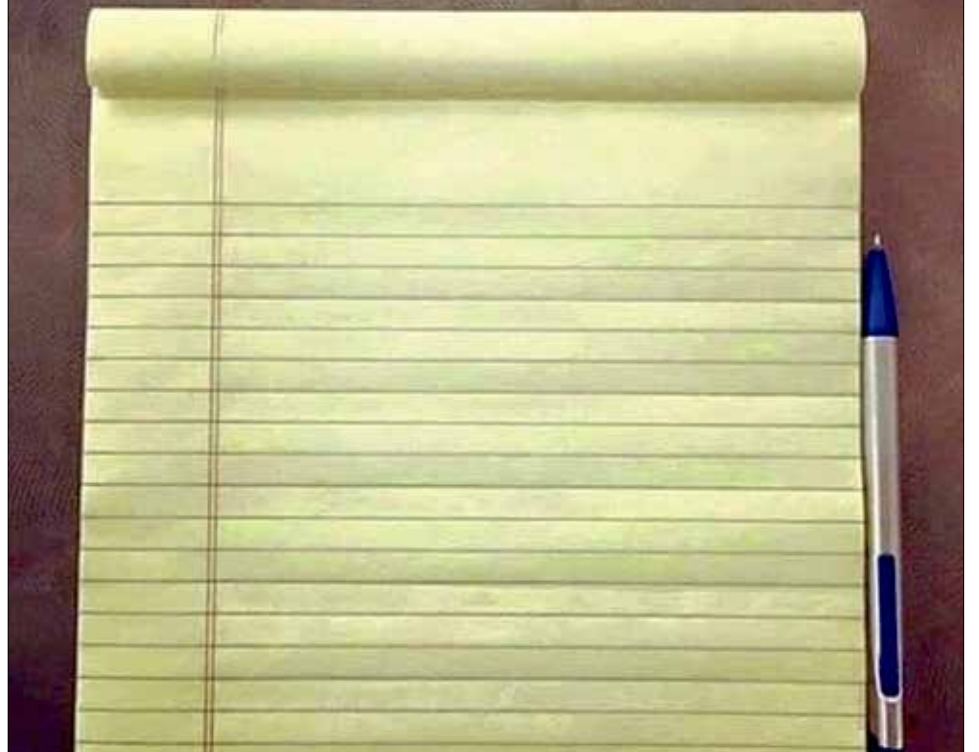

## **Hopkinton woman found in car stuck on Warner OHRV trail**

A missing woman was found stranded in her car on an off-highway recreational vehicle trail in Warner on Monday afternoon.

The 39-year-old woman was reported missing out of Hopkinton. Her family members had last seen her on Saturday, and she notified her family Sunday evening that she got her car stuck on an OHRV trail.

As of Monday, the woman was no longer answering her phone, and no one had been in touch with her for 12 hours, officials said.

New Hampshire Fish and Game officers started looking in the area and found the woman and her vehicle around 2:30 p.m. on Monday on a trail in the Bound Tree trail system.

The car was stuck in rough terrain, and the trail was under high water in some places because of recent heavy rain. Officials said cars should never be on OHRV trails.

“Due to recent heavy rain and flooding these areas are particularly rough and unpredictable,” officials wrote in a news release.

## **New Boston moving forward with Community Power Plan**

Daryl Luter explained that the Town voted to approve a Community Power Plan at the last Town Meeting. The next step in the process was for the Power Plan to be approved by the Public Utilities Commission (PUC). With one minor amendment to the Plan, this was approved. The second step in the process will be a community education and outreach program. After that, there will be a competitive bidding process, with an intention to implement the Plan later this fall. Emily Manns explained

that once competitive pricing has been received, there will be a 40-day information blitz to the Town. Everyone will receive information through the mail. She noted that Eversource has stated that it will have a significantly reduced rate change starting in August.

The launch of the Power Plan for the Town will have additional savings from this rate change. She noted that this Plan is at no cost to the Town and the Town is not obligated to move forward with it.

## Weare man facing felony charge in girlfriend's death arrested again

A Weare man, already facing felony charges after leaving the scene of a fatal crash involving his former girlfriend, was in court again to face a domestic violence charge.

Thomas Hanley, 30, was arrested and charged with four counts of domestic assault for pushing, berating and forcing Gina Maiorano, then 27 and now deceased, into a car they were driving in January. As a result, a domestic violence protection order was filed against Hanley, who violated it in the following days when he sent Maiorano a picture of himself holding a gun and called her several times. Hanley pleaded guilty to the charge, and



was sentenced to 30 days in jail to be suspended for a year on the condition of good behavior and the completion of a 96-day treatment program. Hanley is scheduled to appear in Merrimack County Superior Court in August on felony charges of conduct after an accident, and a breach of bail and stalking, misdemeanors, as a result of Maiorano's death in June.

At the time of her death, Hanley was driving when he said she jumped out of the vehicle. Hanley never stopped because he was high on meth, he told his father.

Following Hanley's arrest in Weare in January, Maiorano, who was 27 and a mother of two, relocated to Connecticut and lived with her brother before going to rehab. She recently left rehab before her death after she relapsed with Hanley the night and morning before she died.

## Goffstown Select Board approve CivicPlus as town's website developer

The Goffstown Select Board reviewed the Municipal Website Development Project. Town Administrator Horne said over the past year they have met with representatives from three municipal website development companies: CivicPlus, Granicus, and Revize. They have attended demonstrations of the products from each company and have reviewed the many sites that each has developed. IT Director Brian Rae recommended that the Town move forward with CivicPlus for their Municipal Website Development Project.

CivicPlus is recommended because they are the predominant municipal website developer in the region. Their quote includes essential components discussed by Department Heads. It has a strong ADA compliance and no user limit on access to the website. They have advanced website

analytics that will provide detailed website trends, and they provide training, implementation, and migration packages.

The cost is locked in for 4 years and they'd expect a similar increase to other potential software packages. At the 4-year mark, they get a full refresh so if they want to redesign, there would not be any additional cost. This cost is to migrate over what they have now onto the new site. Chair Boyer asked if this has any functionality with an app or any type of mobile features. Town Administrator Horne said it's much more mobile friendly. It doesn't have a separate app but is adaptive to smart phone technology. Vice Chair Georgantas made a motion to approve the website development project with CivicPlus as proposed and to authorize the Town Administrator to sign the contract to take advantage of current available pricing.

## Belmont man indicted in connection with Franklin double murder

A Belmont man has been indicted on charges connected to his possession of a firearm recovered during a homicide investigation in Franklin last month.

Justin Gebo, 28, is facing three counts of being a prohibited person in possession of a firearm including being in possession of a firearm while indicted, being a felon in possession of a firearm and being a user of illegal drugs while in possession of a firearm.

In the months prior to the homicide, Gebo was believed to be in possession of a short-barreled rifle in January and February that was later recovered from the scene of the fatal shooting on Elkins Street on June 3. Investigators learned the gun located at the scene of the murders was bought in April 2019 in Hooksett and sold to several different owners before it was purchased by Gebo in January.

While the firearm, a CZ Scorpion EVO, was recovered

from the scene of a double shooting homicide in Franklin, authorities have not confirmed it was the same weapon used. The ongoing investigation will look at the gun's involvement in the homicides and if the alleged suspect, Jamie Bell, was ever in possession of the firearm.

Investigators learned that Gebo and Bell had known each other for the last 20 years and that Gebo admitted to using illegal substances, specifically methamphetamine, following the homicides.

On June 3, police were called to the Elkins Street home, which was shared by Bell, Nicole Hughes and her two daughters, aged 18 months and five years, for reports of a shooting. Officials said Bell, 42, shot and killed Hughes, 35, and their toddler, Ariella Bell. He also wounded Hughes' five-year-old daughter, who survived and was released from the hospital the following day.

Bell was found dead on the banks of the Merrimack River following a six-hour manhunt. According to the autopsy, Bell died of a single, self-inflicted wound and his cause of death was ruled a suicide.

## Department heads update the Bradford Select Board

Lois Kilnapp gave the Bradford Select Board an update on the Transfer Station during the June 26 meeting. She reported that all is running smoothly and on schedule at the Transfer Station. She was asked about the Dept. of Environmental Services Permit and Operating Plan. It was decided that both needed to be updated.

There was a discussion about the use of the entrance to the Transfer Station off Route 103. The Highway Dept. uses this entrance often; others are accessing the burn pile and other areas while the gate is open. It was decided that the gate will stay open when the Highway Department needs to access the area. Lois will get clarification regarding signage at that entrance.

Steve Hall gave the Highway update: The Road Crew has been working on washouts since the June 10th weekend

rain event. The sinkhole at the Fire Station sidewalk has been an issue for some time, however, it is progressively getting worse. The Town is maneuvering to get out in front of the problem before there is a culvert failure. There is work to be done ahead of construction, including permitting and engineering. Their engineer from Hoyle Tanner is working with them on the issues.

Other things the crew reviewed during the June 26 meeting included the clean-up of the old telephone pole fence at Brown Shattuck Field, the Naughton Property prep work for the July 4th celebration, the replacement of culverts and other tasks to prep roads for paving. Chip sealing was scheduled to take place the week of June 26th on Old Warner Road, Breezy Hill Road and Sunset Hill Road to add life to the asphalt plus help protect it from the elements.
