The NH Department of Environmental Services has found PCE & TCE contamination at New London Cleaners.

Contamination found at New London Cleaners

Environmental Services concerned with ground water and indoor air quality

Concerned New London residents filled Whipple Hall Tuesday afternoon to hear Tanya Justham and Jeffrey Marts from the NH Department of Environmental Services brief the Select Board on the status of the contamination found at the New London Cleaners building at 98 Newport Road.

The meeting was scheduled in response to Edgewater Strategies' Final Report for two new bedrock wells, at the Twin Pines Development in New London.

The project is seeking the approval for the small community wells, but NHDES can not approve the proposed small community wells due to the presence of contamination (tet-

rachloroethene) in the groundwater produced from the wells, likely from a nearby Hazardous Waste Site at the Cleaners.

The proposed contamination control program does not reduce the risk of contamination at the wells nor does it control the extent or spread of groundwater contamination on the property. Moreover, NHDES believes that use of or any additional pumping from these wells may cause the further spread of the contamination away from the source area site and additional degradation of the groundwater in the wells.

NHDES recommends that the project owner work with the New London Springfield Water system to

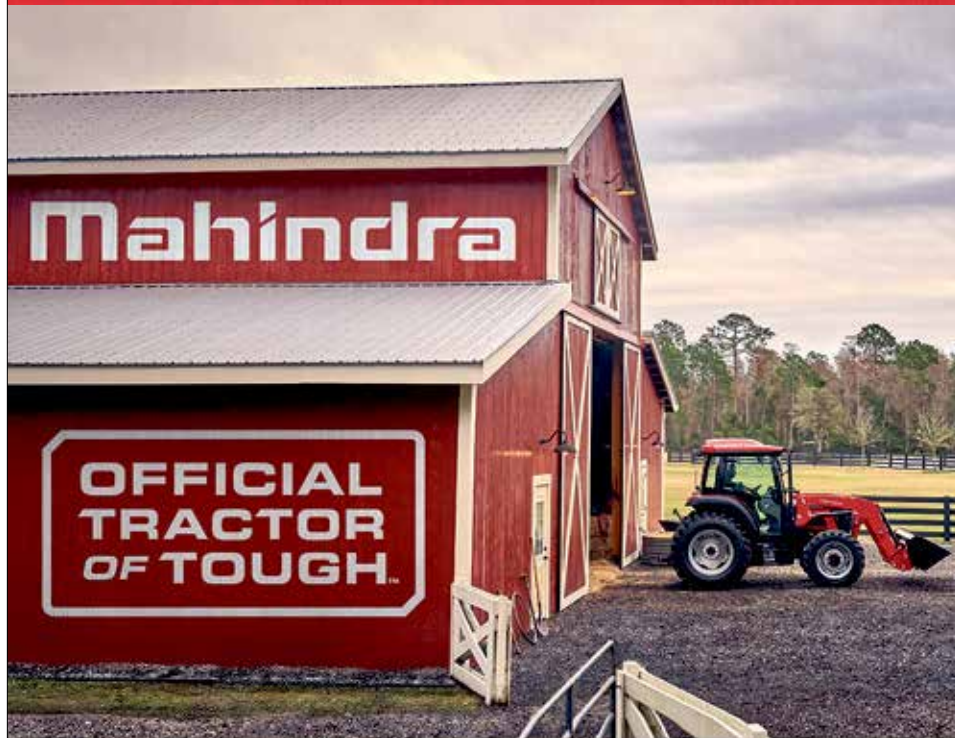
obtain a water service connection.

Justham stressed that although there is no immediate health risk, the contaminants are leaking into the soil and will eventually reach bedrock which could effect more than the nearby wells.

Marts informed the group that it could be a long process to remediate the site. He stressed that the site is no longer leaking but so far efforts to locate the contaminated area have been unsuccessful.

Rep. Karen Ebel (D-New London/Newbury) gave voice to the frustration in the room when it was learned that the contamination was discovered in 2016 and little has been done since then.

New London Select Board supports applying for a \$120,000 Municipal Solar Grant

Jamie Hess, Chair of the Energy Committee, gave the New London Select Board an overview of two municipal grant opportunities related to energy initiatives. The first opportunity is the Municipal Solar Grant Program which allows for up to \$120,000 in federal funds to be used for purchase and installation of municipal solar arrays. The Energy Committee has worked with Granite State Solar to get a quote for installing a 50kW ground mount solar array at the Brush and Metal Disposal Center.

The cost would be \$133,000, which Mr. Hess feels is a reasonable price for the size of the array. The intent is to have \$93,000 paid for by the Municipal Solar Grant Program, and \$40,000 paid for by the Inflation Reduction Act direct pay program from the IRS. That would cover most of the cost, not including some work such as extending power from the

water precinct next door, which could be up to \$20,000.

If this project was to go forward, the town would own the array from the beginning, unlike other existing Town solar arrays of the Public Works garage and at the sewer plant, and all the power generated would defray Town electricity costs for the life of the array.

Selectmen Kidder asked if the design and placement had been considered with regards to visibility by neighbors. Mr. Hess explained that the location would be on the far left of the property, there would be no removal of existing vegetation or trees. Chair Helm referenced the Jones & Beach site assessment done last year. The work done gives the Board confidence that solar panels are a reasonable use for the property. Chair Helm asked that if the grant is awarded, the Energy Committee work with the Department of Public Works to ensure that the

project fits within their use of the space.

The Board agreed to sign a letter of support for the Municipal Solar Grant Program application.

The second grant opportunity relates to the installation of EV Charging Stations, but the Energy Committee does not feel very strongly about applying for the grant. The Board asked Mr.

Hess to focus on the first grant submission, which they are in support of, and declined to vote in favor of pursuing the second grant for the installation of EV Charging Stations.

ENVIRONMENTAL CLEAN-UP COSTS

If no risk is otherwise apportioned among the parties, buyers will bear hazardous waste clean-up costs regardless of their responsibility for the waste, although they may sue responsible parties such as sellers and brokers who fail to disclose reasonably discoverable environmental contamination for reimbursement. New York enforces unambiguous environmental indemnification agreements between private parties, but a minority of states do not, so parties should be aware of choice of law provisions. Survival provisions defining or extending the periods of indemnity or representations are common, but not ubiquitous. Even under long-term survival provisions, buyers cannot be wilfully ignorant of an environmental concern and receive indemnity, creating an implied limitation to the period of indemnity.

Sellers often covenant to provide buyers with environmental audits or assessments before closing, at the seller's cost. Mortgagors may similarly covenant that all construction or development permits obtained and anticipated uses comply with environmental law. Tenants may covenant to comply with environmental matters during their occupation of the property.

Although not typical, sellers may and do indemnify purchasers for acts occurring prior to sale, but sellers will typically cap their indemnification exposure to specific events or limited to specific amounts. Buyers may negotiate clauses allowing rescission if an assessment reveals contamination before closing or deducting clean-up costs from purchase prices. Indemnification clauses frequently require buyers to enable sellers to meet their obligations and provide immediate notification of contaminations to the seller as a condition to indemnification. Buyers may also seek monetary expectation or (if shortly after closing) rescission in court for misrepresentations or the seller's responsibility for environmental law violations.

Three people killed; Peterborough father & daughter survive

On August 17th, troopers assigned to the Troop A barracks responded to reports of a head-on collision between two vehicles. Upon arrival, troopers determined that the driver of a 2010 Toyota Tundra was traveling eastbound at a high rate of speed before side-swiping a 2018 Nissan Sentra, striking a guardrail on the eastbound side, veering across the cen-

ter median and into the westbound lanes of travel, then striking a 2023 Jeep Grand Wagoneer head-on.

The drivers of the Toyota Tundra and Jeep Grand Wagoneer died from injuries sustained in the crash. A passenger in the Jeep suffered life-threatening injuries and was transported to Elliot Hospital by ambulance. That passenger subsequently died from their injuries

at the hospital.

The driver and passenger of the Nissan Sentra, identified as Timothy McMahon, 57, and Kelly McMahon, 18, both of Peterborough, suffered non-life-threatening injuries and were transported to Elliot Hospital as a precaution.

While speed appears to be a factor in the crash, all aspects remain under investigation.

DENTAL CARE TIPS FOR PEOPLE WITH DEXTERITY CHALLENGES

Q: Severe arthritis limits my hand use. Any tips for dental care?

A: You're among the thousands of Americans who suffer from diminished dexterity and find ordinary daily tasks to be challenging. And thousands more have a temporary impediment, like a cast on a wrist or tennis elbow, or some other pain that makes actions like brushing your teeth or flossing difficult. You don't want to let a chronic or temporary impediment interfere with your home oral care, so here are a few tips on how to alleviate the situation:

- An electric toothbrush, which has a thicker handle and does much of the brushing work for you, may be a good first step.
- You can make your regular toothbrush handle easier to grip by wrapping a sponge around it, or by inserting the handle into a rubber ball in a slit that you can put in it, or inserting the brush into a bicycle handle grip. You could also wrap an elastic bandage or adhesive tape around the grip.
- You could lengthen the toothbrush handle by tying a piece of wood or plastic, like a ruler, say, or a tongue depressor, to it.
- Regarding flossing, try buying one of the many over-the-counter devices that are designed to make flossing easier.

Talk with your dentist about other ways to address any temporary or permanent impediment that is keeping you from thoroughly brushing and flossing.

TAKE YOUR MEDICINE

New research reveals that the nation's most widely prescribed type of sedative may be less effective than clinicians and scientists have been led to believe, based on publications in medical journals. The study, published in the journal *Psychological Medicine*, examined both published and unpublished data from five randomized controlled clinical trials reviewed by the Food and Drug Administration for alprazolam, known by the trade name Xanax XR. It is one of a class of sedatives known as benzodiazepines, widely prescribed since the 1970s to treat medical conditions such as anxiety and insomnia. In recent years, benzodiazepines have been associated with serious clinical risks, including dependence, withdrawal, falls and cognitive impairment. This study throws some cold water on the efficacy of this drug. It shows it may be less effective than people have assumed.

A new study in journal *Science Advances* shows that trifluoperazine, an anti-anxiety drug used since the 1950s, can improve the effectiveness of chemo-radiotherapy towards glioblastoma, or GBM, the most common and lethal brain cancer. Brain cancers kill more children and adults under 40 than any other cancer. They are resistant to therapies that kill cancers elsewhere in the body.

A new large-scale study at the American Academy of Child and Adolescent Psychiatry conference has found the drug metformin can help prevent or reduce weight gain in youth taking medication to treat bipolar disorder. Medications to treat bipolar disorder, known as second-generation antipsychotics (SGAs), are often effective at helping young patients' mental health improve but can have significant side effects including elevated blood pressure and glucose, increased appetite and weight gain.

Sunapee, Newbury & New London units located missing person

On Wednesday, August 14th, Sunapee Fire, Newbury Fire, and New London Fire were called to Lake Sunapee by the state beach for a missing paddle boarder. New London Dispatch advised responding units that the paddle boarder was overdue for their return time and was last seen heading towards Sunapee from the state beach and that no one had seen them for 45 minutes.

After close to 40 minutes of searching the lake, Sunapee Boat 1 successfully located the missing party just South of the state beach. The patient declined medical attention once Sunapee Fire personnel assisted them onto Sunapee Boat 1. Sunapee Boat 1 transported the patient back to the state beach, where they were handed over to personnel from Newbury Fire.

Calls like this show how strong the mutual aid is



between Sunapee Fire, Newbury Fire, and New London Fire. This incident involved one fire boat from Sunapee, one from New London, and two from Newbury working in unison to locate the missing party.

Fracestown Comm. recommends separating Elementary School

The Fracestown School Committee presented its proposal for withdrawal from the ConVal School District to the ConVal Feasibility Study Committee at last Thursday night's committee meeting.

Fracestown began exploring the possibility of leaving the ConVal district after a proposal to change the district's original Articles of Agreement failed, which would have paved the way to consolidating the district's eight elementary schools into four schools, which could have meant the closure of the elementary schools in Dublin, Temple, Fracestown and Bennington. Laura

Mafera and Pat Troy, representing the Fracestown School Committee, presented the committee's recent recommendations to the town's Select Board, recommending the creation of an independent Fracestown School District, which would run Fracestown Elementary School, with middle- and high-school students tuitioning back into the ConVal district. Mafera said the district would most likely remain in the SAU, which is the default in withdrawal situations, stressing that Fracestown's top priority is control over the fate of Fracestown Elementary School.

New London directs architects to study three sites for new police facility

New London Select Board Chair Bill Helm reported that the Selectmen have asked Tony DiLuzio, from Colliers Project Leaders, and Lavallee Brensinger Architects (LBA) to review the structure at 176 Newport Road to see if the building itself is usable for a future police facility. LBA will also be reviewing other sites.

He asked Selectmen Kidder and Casey to share their thoughts on which sites they would like LBA to consider in addition to the existing Buker building.

Selectman Kidder does not want to limit the request to one additional parcel, so she supports asking LBA to review the sites on 0 Newport Road and 198 Main Street. Chair Helm agrees

that waiting to do a site review of 176 Newport Road does not make sense until the structure review is done. Selectman Casey agrees with that approach, and she has been impressed with the work done so far developing the Police program.

Phil Sherman, Police Facilities Advisory Committee member, asked for clarification on the address for parcel 059-010, which is also sometimes referred to as the Bewley Property.

Chair Helm explained that as an undeveloped parcel, the Town has not yet assigned an address to that parcel so the “o” is a placeholder until an address is assigned.

The Board agreed to ask Lavallee Brensinger Architects to review the sites at 0 Newport Road

and 198 Main Street for test fitting, as part of the existing contract, and for Colliers Project Leaders to review the structure at 176 Newport Road for repurposing as a Police Facility.

Francestown Board discusses land donation

The owner of a lot on Poor Farm Road met with the Francestown Select Board to inquire if the Town would be interested in receiving the lot as a gift. Town Administrator Jamie Pyle commented that the land does not have any recreation value. Mr. Heath stated that there is a perennial stream that runs through the property, and while in the vicinity, is not contiguous with other conservation parcels. As it is a lot of record, it does not necessarily restrict future development, but would require extreme erosion control measures to ensure safety of the pond. The Board concluded that there is sufficient purpose in protecting the lot and will seek the advice of the Planning Board and the Conservation Commission.

Mr. Pike presented the Board with an overview of the police department staffing budget over the past five years, including all related benefits. A comparison of coverage hours budgeted and actual over the same time. A proposal to add a 2nd full-time officer has been presented by Chief Douglas. The projected cost increase would be approximately \$65,000/year. The Town's coverage goal has been consistent for over a decade of around 118 hours per week. Over the past five years the Town has only been able to attain up to 86% of this goal and has consistently dropped by 6% annually since 2020. Mr. Pike was requested to break down the data another level and bring the information back for the next meeting.

Hillsboro man arrested after 100 mph pursuit through Antrim, Hillsboro & Henniker

A Hillsboro resident was taken into custody after a pursuit through multiple communities.

On August 14th, Antrim Police Sergeant Christensen was on routine patrol in the downtown area of Antrim. A vehicle was observed to have disregarded the stop sign at the intersection of Concord Street and Main Street.

Sergeant Christensen lost a visual of the suspect vehicle in the area of Clinton Road and Old North Branch Road; however, Antrim Police Officer Girard was in the area and attempted to affect a stop on the vehicle at the intersection of Clinton Road and Keene Road (NH Rte 9). The driver refused to stop for Officer Girard and began traveling eastbound

on Keene Road, with speeds reaching in excess of 100 mph.

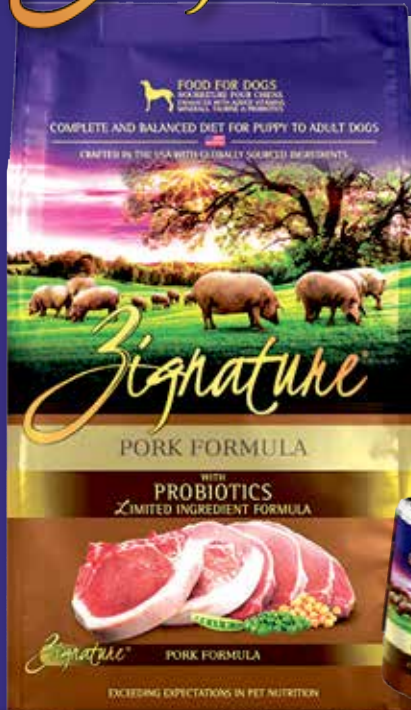
The vehicle continued eastbound on NH Rte 9 into the Town of Hillsboro, where Hillsboro Officers took lead of the pursuit.

He was held at the Hillsborough County Jail pending arraignment in the Hillsboro District Court.

Weare Officers presented Police Commendation awards for Pipe Bomb incident

During the evening hours of April 26, 2023, an explosion took place near 362 Dustin Tavern Road. First responders arrived on scene and conducted a thorough initial investigation in conjunction with investigators from the Department of Alcohol, Tobacco, Firearms, and Explosives, Federal Bureau of Investigations, the Department of Homeland Security, and the New Hampshire State Police.

A subsequent explosion occurred just before 7:00 a.m. on Thursday, April 27, 2023, near 16 Sugar Hill Road, where a passerby suffered minor injuries.

Through collaboration between the various law enforcement agencies, investigators were able to identify the vehicle used to leave the devices in place using surveillance footage.

On April 27, 2023, at approximately 6:00 p.m., members of the Weare Police



Department located the vehicle, and a suspect was immediately detained.

A search warrant was executed on the suspect's vehicle and at his residence.

A fully constructed inferno device, aka pipe bomb, was seized during this step in the process.

The New Hampshire State Police Bomb Squad responded to the scene and neutralized the inferno device.

The investigation into these incidents was complex and multifaceted. Through hard work, determination, dedication, and cooperation, members of the Weare Police Department and

their law enforcement partners were able to arrest the suspect within 24 hours of the initial explosion. The case has subsequently been adopted by the United States Attorney's Office for prosecution.

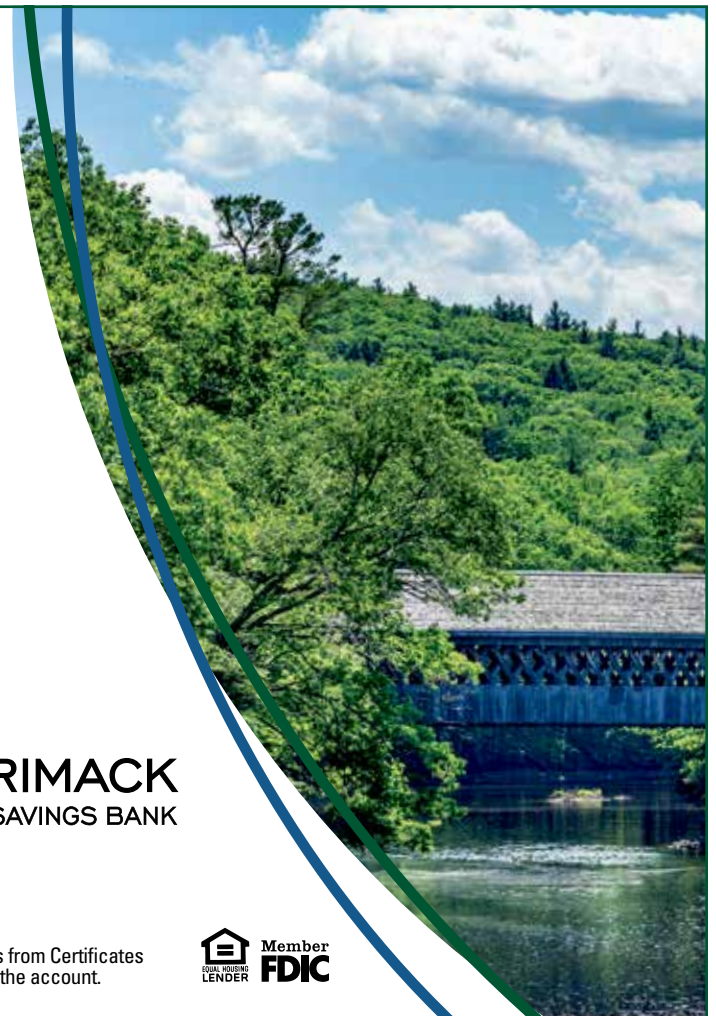
